Rules of Participation

- To reserve a space, please submit a signed application and participation fee:
 - By April 15: \$35 per space; complimentary advertising on posters and social media
 - After April 15: \$45 per space
 - Inside Space: \$50 per space (includes table, if needed)
- Tables are available on a first-come, first-served basis for an additional \$10 fee (table is included with inside spaces).
- Checks and money orders are accepted. All payments are non-refundable.
- Outside spaces are on grass or pavement and are approximately 10 feet x 10 feet. Tents are permitted. Electricity is not provided. Spaces are assigned by the Craft and Vendor Fair committee.
- Limited parking will be available. Instructions will be provided to exhibitors. No vehicular access in the set-up area; exhibitors will be required to park and walk to their space.
- The event begins at 9AM on May 20. Exhibitors may begin set-up at 7AM and must stay until 4PM, unless otherwise determined by the event committee.
- Signs within the booth are permitted and must be of an appropriate nature. Loud or offensive exhibits are not permitted.
- Smoking is not permitted on church property.
- If required by law, any Commonwealth, county, and/or township permits needed to conduct business may be requested the day of the Craft & Vendor Fair.

Terms and Conditions

- Exhibitor hereby represents and warrants that: (I) it (and all who act in its behalf) has the full right and legal authority to enter into and fully perform this Agreement in accordance with its terms without violating the rights of any other person; (II) its Marks do not infringe the trademarks, names or other rights of any other person; (III) it has all government licenses, permits or other authorizations necessary to participate in the Event contemplated under this agreement; (IV) it will comply with the Terms and Conditions for Participation as well as all applicable laws, regulations and ordinances pertaining to the promotions and conduct of this Event.
